Use of the walk in cooler for limited items, if space is available.

The wedding party is responsible for set up and clean- up of lodge and grounds,

for private use. No meals are included. The staff will be available to help as needed.

Maximum of 10 people per cabin. (extra cabins are \$25.00 per person)

Use of the refrigerator and microwave in the lodge.

Use of the walk in cooler for limited items, if there is space available.

The wedding party is responsible for set up and clean-up of lodge and grounds,

(refer to Operating Policy # 6.)

Due to Insurance restrictions and camp policy, the kitchen is not available for

private use. No meals are included. The staff will be available to help as needed.

Fee includes generator and garbage removal. Ice is available.

Your \$500.00 deposit may be refundable upon inspection after checkout. Any additional cleaning by staff will be charged \$50.00 an hour. Any remaining refund will then be paid within 30 days.

If damage occurs over the \$500.00 security deposit, future charges will be applied.

Deposits are Non-refundable if canceled 30 days or less prior to scheduled arrival date.

Contract balance will be paid in full 10 days prior to arrival.

We are requiring all group camps to provide a certificate of Insurance (can be from homeowner's policy) naming Lake Creek Youth Recreational Camp, Inc. as additional insured.

Please return proof of affidavit of such with the signed contract and deposit.

All children and youth need to be supervised by adult family members. Each camp will be responsible for their First Aid supplies and their campers' medical needs, bedding and toiletries. Fitted twin sheets are available for use.

RELEASE AND HOLD HARMLESS AGREEMENT
