A \$500.00 security deposit secures your contract date.

A signed contract is required to make reservations.

Your date will be confirmed as soon as we receive your deposit.

Deposits are Non-refundable if canceled 30 days or less prior to scheduled arrival date.

Upon inspection and no damage occurs, the deposit will be applied to the camp fees.

If damage occurs over the \$500.00 security deposit, future charges will be applied.

ORS 30.260-30.300 and the Oregon Constitution, Article XI, Section 7***

Contract balance will be paid in full to camp hosts before departure.

A fee of 2/3 of 1% interest per month will be charged on unpaid balances over 45 days.

We are requiring all group camps to provide a certificate of Insurance (can be from homeowners' policy) naming Lake Creek Youth Recreational Camp, Inc. as additional insured.

Please return proof of affidavit of such certificate with the signed contract and deposit.

All youth need to be supervised by adults or counselors.

Red chairs from the Lodge will be kept inside at all times.

Each camp is responsible for recreational equipment, belonging to LCYC, and will return equipment to its proper place.

Equipment used for firearms and /or archery programs must be stored in locked compartments, according to State Law!!

Each camp will be responsible for their First Aid supplies and their campers' medical needs, bedding and toiletries. Fitted twin sheets are available for use.

RELEASE AND HOLD HARMLESS AGREEMENT
