**If damage occurs over the \$500.00 security deposit, future charges will be applied.**

**Deposits are Non-refundable if canceled 30 days or less prior to scheduled arrival date.**

**Contract balance will be paid in full 10 days prior to arrival.**

**A fee of 3% interest per month will be charged on unpaid balances over 30 days.**

**We are requiring all group camps to provide a certificate of Insurance (can be from homeowner's policy) naming Lake Creek Youth Recreational Camp, Inc. as additional insured.**

**Please return proof of affidavit of such with the signed contract and deposit.**

**All children and youth need to be supervised by adult family members.**

**Our camp staff is not responsible for the supervision of your children.**

**Red chairs from the Lodge will be kept inside at all times.**

**Each camp is responsible for recreational equipment, belonging to LCYC, and will return equipment to its proper place.**

**Each camp will be responsible for their First Aid supplies and their campers' medical needs, bedding and toiletries. Fitted twin sheets are available for use.**

**RELEASE AND HOLD HARMLESS AGREEMENT**
